

## 2015 Revision of gtPathways Competencies

## Statutory justification: §23-1-125(3), Colorado Revised Statutes:

...The [gtPathways] core of courses shall be designed to ensure that students demonstrate competency in reading, critical thinking, written communication, mathematics, and technology... Individual institutions of higher education shall conform their own core course requirements with the guidelines developed by the department and shall identify the specific courses that meet the general education course guidelines. Any such guidelines developed by the department shall be submitted to the commission for its approval...

# **CDHE Interpretation:**

- 1. Statute does not limit the gtPathways competencies to those referenced above so we can add others as long as the ones referenced in statute are included, no matter if the name of the competency is modified.
- 2. gtPathways competency guidelines are developed by CDHE in collaboration with the institutions of higher education and approved by the Commission.

#### **Timeline:**

- November 2005 gtPathways competencies were last revised.
- April 2014 Written Communication and Mathematics faculty convened to begin
  revising gtPathways content for CO1, CO2 & CO3, as well as MA1, into measurable
  learning outcomes. A little more work was done over summer 2014 and then was put on
  hold. This work is preserved on CDHE's server.
- September 2014 Broad group of Directors of Assessment, many of whom are members of the Colorado Regional Assessment Consortium (CORAC), met with CDHE and it was decided that the competencies would be a better place to start with revisions, rather than the content, because the competencies span all gtPathways categories and can more easily be written as measurable learning outcomes and, thus, assessed. Rationale: HLC is asking institutions to document their gen ed assessment processes. Also, having more rigorous, up-to-date competencies that are already being used at many institutions nationally and in Colorado will assist institutions in their assessment programs and with HLC accreditation and also provide a resource to faculty. Thus, the Fall 2014 Fac2Fac was cancelled and the content revisions put on hold.
- November 2014 April 2015 Select team of Directors of Assessment revised gtPathways competencies, aligned with AAC&U's LEAP VALUE rubrics as well as Passport Initiative Student Learning Outcomes. Draft, revised competencies were vetted with GE Council February 2015 and with Directors of Assessment [date?].
- Draft, revised competencies will now be vetted with faculty at the April 24, 2015 Fac2Fac and online.
