At its June 4<sup>th</sup> meeting, the Colorado Commission on Higher Education approved extensions to June 30, 2011, for all institutions with performance contracts with an expiration date of June 30, 2009. The attached amendment will extend the University of Colorado's performance contract to June 30, 2011.

As you now, the extension is intended to maintain the status quo while the Commission carries out a strategic planning effort over the next 16 months and enables the results of that effort to be reflected in possible revisions to the performance contracts that may need to be negotiated.
