Thank you for forwarding to me a copy of your letter to Dr. Phil Langerman concerning the status of Adam University's conditional extension of approval from the Colorado Department of Higher Education. As we discussed, I had planned on making a preliminary assessment visit on July 23rd to Adam University in Colorado, followed by a short visit to their potential branch in Atlanta on July 24th.

Upon further discussions with Dr. Langerman, it became apparent to ACICS that Adam University does not have any substantial physical presence in Colorado. Their students seem to be located in several international locations. Therefore, I have decided not to visit Adam University in Colorado. I have informed Dr. Langerman that we will be happy to consider any future developments at the Atlanta location if they are properly approved by the State of Georgia and they demonstrate that they meet minimum eligibility requirements for applying for an initial accreditation status with ACICS.

I am contacting you to get some information on Adam University. Adam University was granted authority in Colorado to begin to recruiting, instructing and graduating students on January 10, 2005 based on a statutory agreement to maintain continuous efforts toward accreditation. He was to have twenty-four months to complete accreditation with a U.S. Department of Education approved accreditation body. He requested and received an extension to July 1, 2009 and is now requesting another extension until the end of the year. I am following up with you to find out where the institution is in this process and how long you have been working with Dr. Langerman in his efforts.
