

TOPIC: REAUTHORIZATION OF EDUCATOR PREPARATION UNIT AT ADAMS STATE UNIVERSITY

I. SUMMARY

This item recommends reauthorization of the educator preparation unit and educator preparation programs at Adams State University.

II. BACKGROUND

Pursuant to C.R.S. §23-1-121 the Colorado Commission on Higher Education (CCHE) considers reauthorization of all educator preparation programs at public and private institutions of higher education, after receiving an affirmative recommendation from the State Board of Education. The process for reauthorization of educator preparation programs is as follows: Colorado Department of Education (CDE) conducts a review of the endorsement programs to ensure that the content is designed and implemented in a manner that will enable a candidate to meet the requirements for licensure in Colorado (C.R.S. §22-60.5). Department of Higher Education (DHE) reviews the unit and its programs for the following statutory performance criteria: admission system; ongoing advising and screening of educator candidates; integration of theory and practice in coursework and field based training; supervised field based experience; and assessment of candidates' subject matter and professional knowledge and ability to apply the professional knowledge base [C.R.S. §23-1-121(2)]. DHE and CDE then jointly conduct an on-site visit of the unit and its educator preparation programs. CDE then makes a recommendation to the State Board of Education, which then makes a recommendation to DHE. Upon receiving an affirmative recommendation, DHE makes a recommendation to CCHE.

III. STATE BOARD OF EDUCATION APPROVAL

At its meeting on June 12, 2013, the Colorado State Board of Education approved the content of the educator preparation programs at Adams State University. CDE staff transmitted State Board of Education's approval of the following endorsement programs:

- Art Education (8.04)
- Business Education (8.05)
- Counselor, School (11.09)
- Drama (8.07)
- Early Childhood Education (8.01)
- Elementary Education (8.02)
- English Language Arts (8.09)
- Foreign Language (8.10)
- Mathematics (8.14)
- Music (8.15)
- Physical Education (8.16)
- Principal (3.03)
- Reading Teacher (10.03)
- Science (8.17)
- Social Studies (8.18)
- Special Education Generalist (9.06)

It should be noted that Culturally and Linguistically Diverse Education (8.22) was approved separately at the Commission's October 4, 2012 meeting.

IV. DEPARTMENT OF HIGHER EDUCATION REVIEW

Pursuant to C.R.S. §23-1-121 Department staff reviewed the educator preparation unit and its programs and confirmed that they meet performance criteria.

V. STAFF RECOMMENDATION

That the Commission reauthorize the educator preparation unit and educator preparation programs at Adams State University.
