It is understood that the Division of Private Occupational Schools, upon review and evaluation of this application, may require further information to be submitted and shall conduct such investigation and appraisal as it deems necessary and appropriate prior to approval. An application may be denied if the applicant has furnished false or misleading written or oral statements, documents, or other representations to the Division of Private Occupational Schools with the intent to mislead or conceal the truth of any matter to be considered by the Division of Private Occupational Schools as a factor in approval of the application. It is your obligation to make reasonable inquiry before completing this application to ensure its accuracy and completeness.

- I. The following materials shall be submitted and become a part of this application. If not readily identifiable, please affix school name.
 - A. A surety bond in the sum of \$50,000, as required by C.R.S. 12-59-115(8)
 - B. Application(s) for out-of-state agent's permit with accompanying fee of \$500
 - C. Copies of documents relating to the school's authorization to operate in its home state.
 - D. Copies of any accreditations or other approvals held by the school, if applicable.
 - E. A published catalog containing the information required in the Rules & Regulations. Catalog must contain statement "Agents licensed by the Colorado Department of Higher Education, Private Occupational School Board."
 - F. Copies of all media advertising and promotional literature intended for use in Colorado, which include the school name, address, telephone number, and locations where training will be offered.
 - G. Copies of all student enrollment agreements or other instruments evidencing indebtedness and intended for use in Colorado, which must comply with the provisions specified in Colorado Rules & Regulations.
 - H. The name and Colorado address (no P.O. Box) and phone number of a designated agent upon whom any process, notice or demand may be served.
