NOTICE OF PUBLIC RULEMAKING HEARING

Subject: Proposed Changes to Rules and Regulations for clarification and revision of definitions; language improvement; correction of technical errors and omissions; and in reflection of the further development of Board policies regarding the conduct of its work and the implementation of the Act.

Pursuant to sections 12-59-105.3(1)(j), (l) and (n); and 24-4-103 of the Colorado Revised Statutes you are hereby advised that the Colorado Private Occupational School Board will hold a public rule making hearing **on Tuesday, September 27, 2011, commencing at 9:30 A.M., at the Auraria Higher Education Campus, Tivoli Student Center, Room 320, 900 Auraria Parkway, Denver, CO 80204**, for the purpose of considering revision to the Rules and Regulations concerning the Private Occupational Education Act of 1981 ("Act"), as amended and specifically, for the purpose of clarifying and revising definitions; improving language; correcting technical errors and omissions; and to reflect further development of Board policies regarding the conduct of its work and the implementation of the Act.

It is requested that written testimony be submitted to the Director of the Division of Private Occupational Schools by no later than Friday, September 16, 2011, at 1560 Broadway, Suite 1600, Denver, Colorado 80202. All submissions will be considered.
