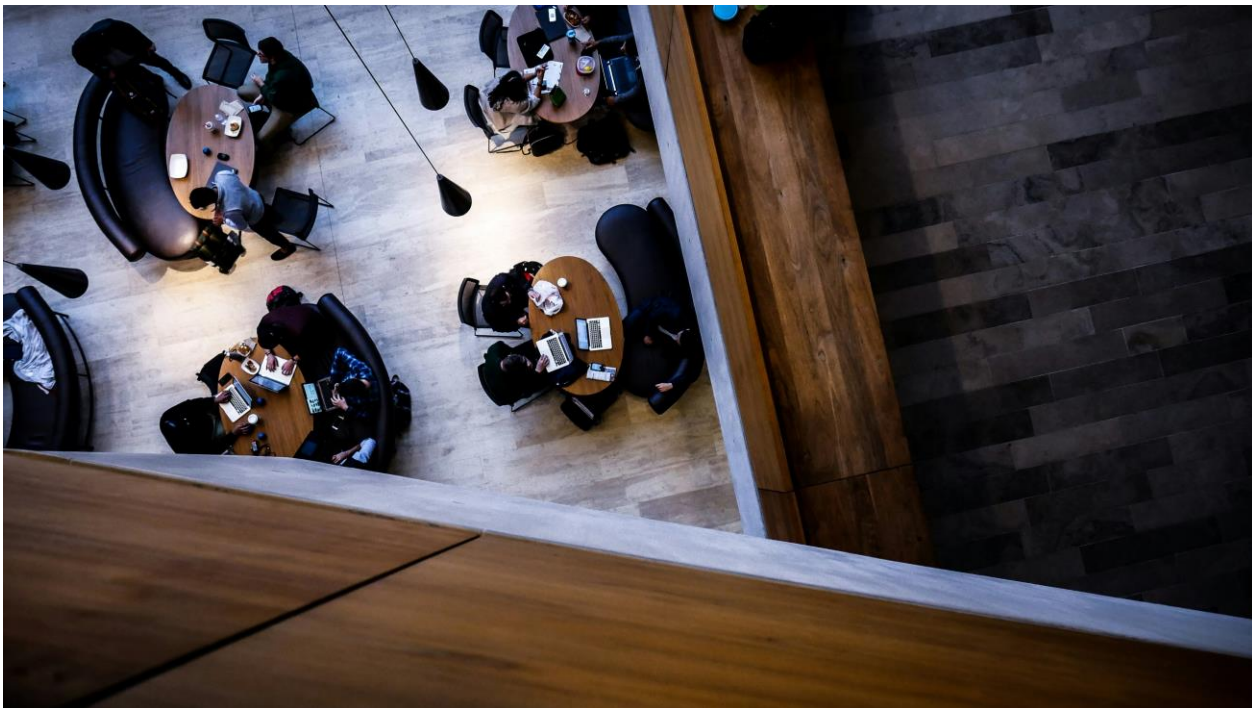

Introduction

Colorado Revised Statute §25-5-113.5, created from House Bill 22-1049 *Concerning Prohibiting a Postsecondary Institution from Making Payment of an Outstanding Balance on a Student's Account a Condition of Issuing the Student's Documents*, directed the Colorado Department of Higher Education (CDHE) to collect and report transcript and registration holds annually from each postsecondary institution. This report includes the following:

- The postsecondary institution's policy regarding holds;
- The number of students for whom the postsecondary institution is withholding official transcripts, diplomas, and registration privileges; and
- The number of past-due student accounts assigned to third-party collection agencies, including the number of students who are eligible for federal Pell grants.

Beginning January 2025, and each January thereafter, CDHE shall annually report on the information reported by the institutions at the department's annual State Measurement for Accountable, Responsive, and Transparent (SMART) Government Act hearing.

While the statute allows institutions to withhold transcripts and diplomas from current and former students who owe a debt for tuition, room and board, and financial aid funds, it also provides rules which prevent institutions from withholding these college documents. These rules include that institutions shall not withhold transcripts and diplomas for students who owe a debt for expenses that are not tuition, room and board fees, or financial funds. Further, the college documents shall not be withheld if the student can demonstrate that they are needed for one of the following reasons:

- A job application;
- Transferring to another institution of higher education;
- Applying for state, federal, or institutional financial aid;
- Pursuit of opportunities in the military or national guard; or
- Pursuit of other postsecondary opportunities.

Finally, institutions of higher education are directed to create and provide students with transcript and diploma hold information, by making these policies available on their websites.

Totals for the 2025 Academic Year:

- The total number of students institutions withheld official transcripts, diplomas, and registration privileges due to student debt: 76,984 (55,313 in 2024)
- Total number of past-due student accounts assigned to third-party collection agencies: 53,167 (43,275 in 2024)
- Number of past-due student accounts assigned to third-party collection agencies who were Pell eligible: 11,525 (8,752 in 2024)
- 21.7 percent of students sent to collections were Pell eligible (20.2%)
