- The GT-HI1 submission form is missing the Additional Requirement for Designating a History Course as GT Pathways: "a GT Pathways History course must also require in-class writing and a graded outside-of-class writing assignment that applies historical concepts to a question in the discipline of history." This got revised and posted.



- Discussion on the “verify” statements that provost agrees to. Noted that while provost can verify there’s a process and expectation that all faculty will adhere to GT Pathways requirements, realistically there’s no way to ensure/enforce/verify what actually happens at the classroom level.
- LMS “chunks” syllabus, which makes it challenging to include content criteria and competencies. CSU found a way to maintain memory of the syllabus with content criteria and competencies in its LMS. Ian checking with Kelly and Patrick. CSU’s way around this is that the syllabi will be attached when a course goes through its Curriculum Information System en route to University Curriculum Committee. It will then be stored in the persistent memory on Banner.

- Potential topics so far: Include GEC mission and goals; priorities; look back at old priorities to gauge if GEC accomplished them -support for these; consider the language “GEC shall recommend to CCHE” in Policy I,L; relationship of state government to governing boards and CDHE organization—support for this; D grades in associate degrees and DwD course substitutions including when student completed a higher course than the one required (e.g., completed calculus but not the required college algebra)—put this on March agenda; DwD enrollment and persistence to bachelor’s data; What else?

- Step away from everyday practice/topics and broaden view- provide wider/higher perspective.
- Good topics for retreat: a history of GE Council; discussion of reports like the demographer's report at the last CCHE meeting and the Talent Pipeline Report; High Impact Practices (HIPs); Math Pathways Task Force update; history of why the number of credits per GTP category; advisor input on DWDs and how/if they're being used.

1. When the original STAAs were made, the CCCS system had no GT-SC2 (non-lab) science courses, so there was no way to finish the Science requirement in 7 credits. Now that the CCCS system has non-lab GT-SC2 courses, it is possible to complete an associate's with 7 science credits. Older STAAs might benefit from revising these course options?
