- III. INFORMATION ITEMS (1:10-1:45)
  - 1. CCHE Meeting Debrief (Kim Poast, Chris Rasmussen, Wayne Artis, Chad Harris)
    - Revisions to funding formula
    - CCCS BSN program update and GT Pathways waiver request—blanket waiver vs. limited waiver vs. modification? (see discussion item below)
    - Legislative update
    - Revisions to CCHE Policy on Statewide Transfer and GT Pathways (see discussion item below)
    - The Commission continued its conversation about affordability and developing a standard/definition, and principles that should guide the development of a definition. The Commission heard a presentation from HCM Strategists on performance funding across the US and how different states incorporate different incentives and areas of focus into their funding formulas. A bill introduced or to be introduced in the General Assembly this session would charge the CCHE with engaging in a review of the funding formula every five years.

- Nursing and GT Pathways waiver request
  - The Commission received an update from CCCS regarding the rollout and implementation of the BSN programs at seven institutions.
  - CCCS requested a GT Pathways waiver for all BSN programs. Typically, waiver requests are done in conjunction with program approval, so this is a unique case (since the programs were approved by the State Board in July). This has caused CDHE to rethink the GT Pathways waiver process. The staff developed questions to ask of institutions that are seeking a waiver.
  - There was discussion at the CCHE meeting about a limited waiver (or "modification") vs. a blanket waiver. CCCS is requesting to exchange one course for another (GT-SS for GT-AH) and drop the history requirements. What would the accountability mechanism be if we were to start exchanging classes? Should we have a more defined process for waiver requests?
  - It was suggested that CDHE enter into a memorandum of understanding with CCCS on the limited nature of the GT Pathways waiver, and that CCCS could be required to provide a status report after X number of years, perhaps in concert with the program's accreditation review calendar.
- Provided info on several other bills that the Department is involved with, or that have been introduced by others that affect higher ed. Christina will send a spreadsheet created by our legislative affairs team that summarizes all of these bills.

## 2. OER Grant Update and Overview of Statewide Training and Conference (Spencer Ellis)

- CCHE approved the recommendations made by the OER Council for grant funding.
- OER Council recommended to "spread the wealth" across the state.

  Many proposals were partially funded. Institutions that were not funded were awarded travel grants so that they could attend the OER conference in May.
- Statewide Colorado OER Conference will be held on May 30-31 at the Lowry Conference Center. May 30 will focus more on "train the trainer" with Open Textbook Network. Each institution is being asked to nominate 1-2 people from their campus to send to this training on May 30. Who on your campus will be best equipped to come back and train faculty? May 31 will be broader with various sessions, including grantees from this first grant cycle, to discuss topics such as "how to write a successful grant proposal."
- Spencer suggested that the GE Council might be engaged at some point in curating content for different GT Pathways categories.

- 3. Humanities Advocacy Day(s) in Washington, DC: March 10-12 (Alex Ilyasova)
  - Alex has represented CO for the past two years for this event.
     Unfortunately, she will not be able to attend this year.
  - As of now, no one has committed to representing CO this year.
  - Who would be the ideal person to go? Academic Deans, Department Chairs, anyone who can speak and advocate on behalf of the humanities. No prior experience is necessary. Training will be provided.

- 4. Update on CSU Global Self-Paced Courses for Existing GT Pathways Courses—Course Challenge Option (Chris Rasmussen)
  - Last month the Council discussed a proposal from CSU Global to give GT
    Pathways designation to a self-paced option for 8 existing GT Pathways
    courses. They courses are designed to let students move through them at
    their own pace with instructors readily available to provide feedback
    and to assist students as needed. Students can then pay a fee to take an
    exam to assesses their mastery of course content and competencies.
  - It was suggested in the previous Council meeting that these courses sounded like competency-based education and that perhaps a better approach would be to treat the experiences as prior learning with an assessment attached.
  - Upon further discussion and communication with CSU Global, Chris and Kim suggested that the self-study courses be positioned as "course challenge options" as articulated in the CCHE PLA policy, since CSU Global is essentially giving students an opportunity to test out of these GT Pathways courses. CSU Global reps saw this as a good resolution and will proceed per the PLA policy, awarding GT Pathways credit when scores on the challenge exam are sufficient to merit credit, and transcripting the credits as earned via challenge exam.
- 5. Complete College America related initiatives and next steps for Colorado
  - Complete College America institutional action plans are due to Kim Poast by Friday, February 15.
  - CDHE also needs a roster of institutional team members. In many cases these will be many of the same individuals who attended the Momentum Action Summit in October, but since attendance at that event was limited, institutional teams may include a larger number of people.
  - A tentative date for the CoCoAm Planning Academy has been set for April 25-26 (NOTE: since the meeting, CDHE staff confirmed with CoCoAm staff that the Planning Academy will be held in the fall.
- 6. Spring Fac2Fac tentative date Friday, April 26!
  - Complete College America Planning Academy (April 25-26)
  - Convening of faculty proposing new DwDs/STAAs
  - Speaker on delivering on content criteria and competencies in teaching GT Pathways courses

 The spring Fac2Fac conference will be "co-located" with the Complete College America Planning Academy. Fac2Fac will be held on Friday, April 26, at a location TBD. It will involve groups of faculty across the state to negotiate frameworks and content of new DwDs/STAAs to be identified through a Call for Proposals. There will also be invitations to faculty in certain fields where CDHE has a specific interest in creating new DwDs/STAAs (e.g., engineering and computer science).

#### 7. Updates (and thank you!) on:

- Re-submission of GT Pathways courses (following 2016 revision to GT Pathways content criteria and competencies)
- Prior Learning Assessment policy course equivalencies and portfolio review information
  - CLEP/DSST Tables drafts for posting to CDHE website

  - AP/IB Tables update/affirm by February 28

- Chris and Christina met with a team from UC Denver to review errors in the military course/occupation tables and will update the tables accordingly (addressing missing data, conflicting data, and redundancies). There will be no need for institutions to re-submit tables they have already submitted.
- CDHE will convene an ad hoc working group on PLA policy evaluation tomorrow. The group is composed of registrars, IR staff, and academic deans/provosts.

#### IV. DISCUSSION/ACTION ITEMS (1:45 - 4:00pm)

- 1. Update on CCCS Technical Writing GT-CO1 Course (Chris Rasmussen and Danen Jobe, Vice President for Instruction, Northeastern Junior College)
  - Danen Jobe from NJC and Rhonda Epper from CCD provided additional background information on how the CCCS Technical Writing course was developed. Two documents were sent to Council members as background: a crosswalk of GT-CO1 Content Criteria with ENG 121 (College Comp 1) and ENG 131 (Technical Writing), and an ENG 131 syllabus from Front Range Community College. Danen described the "contextualization" process used in developing the course, which essentially involved taking the framework for ENG 121 and positioning the course toward different discourse communities.
  - Robust discussion ensued about the content of the course and how it was aligned with shared understandings of what a GT-CO1 course should deliver. Without full agreement, the Council saw the course as a "variation on a theme" of ENG 121 and suggested that the course might be renamed (such as "College Composition for Technical Audiences") to distinguish the course from CO2 courses also called "Technical Writing". Danen and Rhonda said that was likely possible but given the March deadline for catalog updates for 2019-20, it likely wouldn't happen for a year or more.

- 2. Affirm addition of Community College of Aurora to the Statewide Transfer Articulation Agreement in Theatre
  - The Council affirmed the addition of CCA to the STAA in Theatre.
- 3. Proposed additional of Trinidad State Junior College to Statewide Transfer Articulation Agreements in Anthropology, Art History, Biology, Economics, English, Philosophy, Sociology, and Studio Art (Lynette Bates, Vice President for Instruction [or designee], TSJC invited)
  - An invitation was extended to TSJC for someone to participate in the Council meeting, but they were unable to attend. Chris did hear from Lynette Bates later in the week with details on changes in faculty and instructional capacity that have enabled TSJC to teach DwD/STAA courses with sufficient frequency to enable them to offer the DwDs listed above and to participate in STAAs. Christina will follow up with the information and the Council will revisit the proposal at its March meeting.
- 4. Draft revision of CCHE policy Section 1, Part L: Statewide Transfer and gtPathways Policy
  - Proposed guidance on "total time to degree":
    - "Total time to receive the degree" presumes that the transfer student and the native student demonstrate substantially similar enrollment patterns in the same program of study.
  - Council affirmed the proposed language.
- 5. GT Pathways request process for program waivers proposed questions for waiver requests:
  - Why it is important that a GT Pathways waiver be granted for this program (address the nature of the degree relative to the profession, if applicable, including work pathways for students entering the program)?
  - How will the institution ensure that the program includes a "core of courses" that provide a general education through which "students demonstrate competency in reading, critical thinking, written communications, mathematics, and technology" (from CRS 23-1-125(3))?
  - How will this "core of courses" respond to the 10 competencies of the GT Pathways curriculum?
  - What additional degree requirements, such as those associated with accreditation and licensure, make it impossible to include the full GT Pathways in the program curriculum?
  - How will the absence of a GT Pathways waiver potentially harm students (if, for example, it extends the time to degree beyond four years, or results in certain critical courses being left out of a program)?
  - How will the institution ensure that the GT Pathways waiver will not unreasonably burden or disadvantage students who transfer into the degree program?

- Council affirmed these questions for future use, although there was concern that the language in the last bulleted item may be problematic (e.g., does "unreasonably" burden suggest that some burden may be reasonable?). Chris suggests changing "will not unreasonably burden or disadvantage students who transfer" to "will not create barriers to student transfer".
- 6. STAA/transfer report update additional data on total credits earned for the bachelor's degree, DwD recipients vs. DwD non-recipients
  - Data was presented on total credits earned by bachelor's degree recipients for associate degree completers. DwD recipients accumulated, on average, four fewer credits in completing the bachelor's degree than did non-DwD recipients.
