UCD: ENVS1042 Introduction to Environmental Sciences (4) Metro: ENV 1200 Introduction to Environmental Science (3)

ENVS 1042 is a SC1 course and ENV 1200 is a SC2 course. According to

the gt-Pathways agreement, both courses should be accepted for Natural Sciences. However, the evaluation of these courses makes them both equivalent to CUB's ENVS 1000, Introduction to Environmental Studies. The best call to make to make given the overlap in content of these courses would be to bring in the ENVS 1042 course for 3 credits as equivalent to our ENVS 1000 course plus 1 credit hour lab credit and not give credit for the ENV 1200 since it is repeated credit for the same course. If the student appeals this decision, what would happen?

Vicki's Response:

I believe your approach makes sense and is fair, (to both the student and the intent of gtPathways). Please proceed accordingly and use my email response as substantiation for your decision. In the event the student complains/appeals to DHE/me, I'll back you up on your decision, (it just makes sense). I'll save this email in my Trans/Art tickler file for future reference, (if needed).
