#### PUBLIC RULEMAKING HEARING

## January 7, 2014 @ 10:00 A.M.

The Colorado Private Occupational Schools Board convened at the Division of Private Occupation School, 1560 Broadway, Suite 1600, Denver, CO 80202 in the Emily Griffith Conference Room.

Thomas Narvaez, Chair called the meeting to order at 10:03 A.M., announcing the purpose of this public meeting was to conduct a rulemaking hearing on the Proposed Amendments to the Rules and Regulations concerning the Private Occupational Education Act of 1981, as amended, and provide clarification and improvement of language, definitions, corrections of technical errors and omission, and to reflect further development of Board policies. The Board will also be considering annual fee setting as required by section 12-59-119, C.R.S., and consideration of adopting a revised fee schedule. ### **Commencement of Rulemaking Hearing:**

Mr. Narvaez, Chair call to order this public rulemaking hearing on the proposed Amendments to the Rules and Regulations concerning the Regulations of Private School, specifically the permanent adoption of the adjustment to fees.

This hearing was properly noticed as part of this public meeting and in accordance with section 24-2-103 of the Colorado Revised Statutes. The statutory basis for the amendments to the Rules is found in section 12-29-105.3(1)(j), (l) and (n).

Mr. Narvaez stated the purpose of the proposed amendments pertains to annual fee setting, pursuant to section 12-59-116, of the Colorado Revised Statutes and other provisions under which the Board by rule shall establish fees for the direct and indirect costs of the administration of the Act. The Board at its public meeting on November 6, 2013, adopted a temporary rule approving the adjustment to fees as noticed herein.

No written testimony or comments were received or no individual or organization requested to testify at the public hearing.

After due deliberation, Mr. Steele motioned for approval to adopt the proposed fee schedule. The motion was seconded and a roll call vote was taken.
