III. INFORMATION ITEMS

- 1. Updates (and thank you!) on:
 - Re-submission of GT Pathways courses (following 2016 revision to GT Pathways content criteria and competencies)
 - Submission of PLA course and transfer equivalencies (CDHE will be following up on the new CLEP exam in Spanish with Writing and to address individual discrepancies in other parts of PLA tables - have fully completed by May 31)



IV. DISCUSSION/ACTION ITEMS

- 1. All things COVID-19
 - a. General reports/observations/bright spots?
 - b. Draft CDHE "Return to Campus" Guidance
 - The Council focused instead on recent events connected to the death of George Floyd in Minneapolis and the proceeding protests and movement for social change. Discussion included use of the equity toolkit for faculty developed by CDHE in partnership with the Equity Champions Coalition; the need for institutions to "education to be critically minded and justice oriented"; revision of policy academy training and criminal justice programs to incorporate much more content on cultural competence and implicit bias; efforts to infuse DEI more intently and systematically across the UG curriculum; efforts to update current diversity courses to dive deeper into social justice and issues of privilege; efforts to diversify the faculty; and the possibility of requiring one of the courses in the AH/HI/SS cluster in GT Pathways to focus on cultural competency and social justice.
- 2. Affirmation of Colorado Northwestern Community College (CNCC) to Statewide Transfer Articulation Agreement in Early Childhood Education
 - No objections were brought to the Academic Affairs team during the public comment window.
 - CNCC has been approved to join the above listed STAA.
- 3. Affirmation of Aims Community College to Statewide Transfer Articulation Agreement in Music
 - No objections were brought to the Academic Affairs team during the public comment window.
 - Aims has been approved to join the above listed STAA.
- 4. Requests for waivers from GT Pathways requirements for selected programs
 - a. Bachelor of Applied Science in Automotive Industry Management at Colorado State University-Pueblo
 - b. Bachelor of Applied Science in Leadership & Organizational Management at Colorado State University-Pueblo
 - Discussion occurred with no concerns raised regarding the curriculum planning by CSU-Pueblo.
 - It was suggested that institutions could use additional guidance on what constitutes a Bachelor of Applied Science degree and how it differs from a BA or BS degree.
- 5. STAA Updates
 - a. SBCCOE approval of DwDs in computer science, dance, journalism, and public health
 - b. Signature documents being prepared
 - c. COAG advisement on mechanical engineering agreement and next steps

- COAG confirmed that the statute does not allow a receiving institution to require additional general education courses that were not completed as part of the associate degree.
- The Academic Affairs team is hopeful that we can use what we currently have as a foundation to move forward and investigate other ways to ensure that students are awarded an associate degree upon completion of general education requirements post-transfer. CCCS and SBCCOE could decide to approve this as an AS degree as is, but without the designation. CCCS could pursue a statutory fix in 2021 so that this and other engineering agreements would be statutorily compliant as Degrees with Designation and part of statewide transfer agreements. It was suggested that the department pursue parallel courses by moving forward with a transfer framework within existing statutory fix

- 6. Strong Start to Finish grant award, workplan, timeline
 - The Department anticipates receiving formal notification about the award the week of June 22.
- 7. Update on HB20-1002 work-based learning and "test out" options
 - The bill remains a priority legislation item for the Department; CDHE is working with sponsors and stakeholders on amendments in response to dramatically changed circumstances, including elimination of any state funding for the work—instead CDHE is seeking gifts and grants.

- 10. (ADDED ITEM FOLLOWING PUBLICATION OF AGENDA) GE Council Sunset Review
 - The GE Council is scheduled to sunset September 1, 2021, and the Department of Regulatory Agencies must complete a review and submit its findings to the General Assembly by October 15, 2020. The Academic Affairs staff is collecting data to share with DORA by July 1, 2020 (membership, meeting frequency, participation, spending, actions taken). The request for information includes an open-ended "reasons why the Council should be continued". In addition to the extended statutory role in implementing HB20-1002 (with reports to the General Assembly through 2029), the Council discussed the benefits of the group to institutions in maintaining the integrity of transfer frameworks, providing an opportunity for input from faculty to the department, and providing a venue for representatives of two-year and four-year

institutions to come together (one of the only—if not the only—regular, structured opportunities for this to happen).
