- 3. Announcements and Discussion Items
 - a. Introduction of Brad Griffith, new Senior Director of Academic Pathways and Innovation Carl introduced Brad Griffith as the new Senior Director of Academic Pathways and Innovation for CDHE and invited him to share information about his background and answer questions from Council members.
 - b. 2025 Colorado Open Educational Resources (OER) Conference (Chealsye Bowley, CDHE)

Chealsye Bowley, Director of Open Education and Learning Innovation, extended an invitation to Council members to attend the annual OER Conference, scheduled for Friday, May 30 at the University of Northern Colorado in Greeley. The theme this year is "Mapping the Open Road: Navigating the Future of OER." Chealsye informed Council members that this year's conference will feature over 20 presentations, workshops, and panel sessions that follow beginner, collaboration, STEM, student engagement, and sustainability tracks – there are sessions for all experience and knowledge levels of open education. Registration details were provided in a follow-up email.


Carl and Brad provided a brief update on several bills that DHE was tracking this legislative session:

- SB25-087 Academic Adjustments in Higher Education: 4/9/2025 Sent to the Governor
- SB25-120 Nuclear Workforce Development and Education Program: 4/29/2025
 House Committee on Finance Refer Unamended to Appropriations
- HB25-1038 Postsecondary Credit Transfer Website: 5/5/2025 Senate Third Reading Passed – No Amendments
- HB25-1041 Student Athlete Name Image or Likeness: 3/28/2025 Governor Signed
- HB25-1186 Work-Based Learning Experiences in Higher Ed: 5/2/2025 Senate
 Third Reading Passed No Amendments
- HB25-1218 Concurrent Enrollment and Higher Education Courses: No updates; postponed indefinitely
- HB25-1221 Emily Griffith Associate of Applied Science Degree: 4/10/2025 Governor Signed

Carl also informed Council members about SB25-276 – under current law, a person who does not have lawful immigration status must submit an affidavit stating that they have either applied for lawful presence or will apply for lawful presence as soon as they are eligible when they are applying for in-state tuition classification. This bill repeals the affidavit requirements for these students.

d. Standardized fee structure for prior learning assessment reviews (e.g., portfolios, workbased learning, industry credentials, etc.)

Brad led Council members in a discussion regarding the landscape of fees for prior learning assessment reviews in the state. Council members reported that fees vary across institutions for prior learning to be reviewed for academic credit. DHE staff expressed interest in exploring a standardized fee structure for prior learning





assessment reviews. Council members encouraged DHE staff to include registrars in this discussion.

e. Updates from CCHE Advisor Michael Lightner

Dr. Lightner informed Council members that he was unable to attend the CCHE meeting that was held on May 2 but attended the CCHE Student Success & Workforce Development Standing Committee that occurred on April 21. He reported that the standing committee has been working this academic year to learn more about the different pathways to postsecondary credentials. The committee would like to provide recommendations on ways the Commission can support access and awareness for these different pathways.

Carl and Brad provided a brief overview of the CCHE meeting – they informed Council members that updates on the statewide longitudinal data system (SLDS) and the funding formula review were provided, as well as the approval of the cannabis-related certificate program at Colorado State University Pueblo.

f. CCHE Advisor position – renewal of Michael Lightner
Carl informed Council members that Department staff extended an invitation to Dr.
Lightner to renew his term as the CCHE Advisor representative for Academic Council. No objections were raised – Council members were enthusiastic that Dr. Lightner would be representing them for another term. Dr. Lightner thanked Department staff for the opportunity to serve for another term and expressed appreciation amongst his fellow Council members for entrusting him to provide the CAO perspective at CCHE meetings.
